APPLICATION FOR SCHOLARSHIP

The Mississippi Municipal Court Clerk's Association provides (3) three scholarship awards each year, to any up-standing members child with the following qualifications. The Scholarships will be in the amount of First place -\$1000.00 ,Second place - \$750.00 and Third place - \$250.00.

Outstanding High School Senior who is the child or grandchild of a MMCCA member (Court Clerk) in good standing, and plan to pursue undergraduate studies at a college of university may apply.

Application's will be taken January 1st through April 15th of each year, the deadline for application is the 15th day of April. The winner(s) will be selected during the Summer Conference and notified immediately. All scholarships will be determined by reviewing of each applicant's application by the Scholarship Committee. Recipient may receive the award earlier that summer due to school starting in August.

APPLICATION PROCESS

- 1) After completing the application form, sign, and mail to the address listed before the deadline date.
- 2) The MMCCA member must sign and date the application form,
- 3) Include three letters of recommendation. The three letters should come from individuals having knowledge of your achievements and potential. On recommendation should be from a school official and one from person other than a relative. Avoid peer recommendation. No more than three letters are required.
- 4) A copy of your latest High School Transcript and ACT or SAT test results should be included or provided. The most recent copy of your college transcript.
- 5) Include a personal essay. It may consist of 150 handwritten words or less. Your career objectives, how college ties into said objectives and how you expect to contribute to society for the basics of your essay. If you choose to be more creative, you may select some other format for your essay, the essay should provide a way in which to become better acquainted with you; by means other than your accomplishments. This enables you to demonstrate your ability to organize your thoughts and express yourself clearly.
